

Synod Council Minutes

September 17, 2022 at St John's in Findlay

1. Welcome and Devotions led by Bishop Daniel in the Chapel.

2. Meeting called to order by vice-president Nancy Yunker at 9:10

3. Financial Updates – led by Treasurer Shea McGrew After Shea led us through the financial updates, the following action items were considered:

Action SC22.24 Consolidation of Council Designated Funds

"Synod Council approves the consolidation of the following Council Designated Funds into the Endowment Fund: Reserves (Boerger), Building and IT, International Travel, Bishop's Discretionary, Rave Scholarship, First Call Theological Education, Synod Assembly Carryover, Churchwide Assembly, Boundaries Workshop, Macedonia (Stewardship), Auto Replacement, Office Equipment Replacement, Program Year, and Candidacy. This action results in one Council Designated fund, the Endowment Fund."

Motion made by Rev. Melanie Haack; second by Rev. Robin Owen. Motion approved.

Action SC22.25 Discontinuation of Budgetary Accruals to Designated Funds

"Synod Council approves of the discontinuation of the budgetary accruals into Council Designated Funds for Auto Replacement and Office Equipment Replacement, retroactive to February 1, 2022. These replacement accruals are to be removed from the operating budget."

Motion made by Tom Ritter; second by Deb Knoll. Motion approved.



Action SC22.26 Realignment of Investments

"Synod Council authorizes the Finance Team to realign the synod's investment portfolio to construct three investment portfolios: one portfolio will be tied to the Council Designated Endowment Fund; one portfolio will be tied to certain Donor Restricted Funds; and one portfolio will be for unrestricted reserves. The Finance Team will invest each portfolio based on the new investment policy.

Motion made by Rev. Mindy Elliott; second by Wendy Bauer. Motion approved.

Action SC22.27 Approval of New Investment Policy

"Synod Council approves the Investment Policy Statement as presented and recommended by the Finance Team."

Motion made by Rev. Brenda Peconge; second by Rev. Melanie Haack. Motion approved.

It was clarified that instead of "Financial Management Committee", the name would be changed to the "Audit Committee/Finance Team" in the investment policy.

Discussion of percentage of NWOS budget given to Church-wide. Currently at 51% of mission support goes to Church-wide. A representative (Nick Kiger) from Church-wide will be with us in December to discuss revising our share downward. Originally thought that NWOS needed to have this decision approved by a Synod Assembly. However, Synod Council can make this decision. Council will act on the recommendations at later meetings.

NWOS was considering a mini-Synod Assembly in September of 2023, but Church-wide does not require synod assembly for this action or for ratifying Church-wide constitutional updates provided the adopted updates are identical to the provisions in the model constitution.

4. Orientation Part Two – Synod Authorized Ministry

Teaching Time: Bishop presented a brief history of the SAM program and the involvement of the NWOS in that program. The following are the components to the program:

Site: need for word and sacrament ministries to a congregation Primary—congregation or ministry

Bishop: authorize SAM with agreement from Site Synod Council: Bishop consults with Council--

SAM: trained or in training for a specific site for a specific time period

Supervisor: supervision by ordained minister of word and sacrament, (appointed by bishop)—report to bishop and congregation

Question: Should Synod Deans and conferences be involved

Guidelines: Will be share in email



Requirements: See requirements for Diakonia program

Next: October meet with current and "mentors" to discuss new guidelines and procedures

Further discussion at December Synod Council meeting.

Action SC22.32 Sale of Bright Road Office

"At the recommendation of the Executive Committee, Synod Council approves entering into a Purchase Agreement with L3G Properties to sell the Bright Road Office for \$487,500."

Motion made by Deb Knoll; seconded by Rev. Melanie Haack. Motion approved.

Distribution of the sale money will be determined at the December meeting. St. John's Lutheran in Findlay will be called the **NWOS Administrative Hub**.

Action SC22.33 Global Mission Board Appointment

"At the request of the Global Mission Board, Synod Council appoints Pastor Brenda Peconge, of Grace Toledo, as the Council's representative to the Board."

Motion made by Tom Ritter; second by Wendy Bauer. Motion approved.

Action SC22.30 Approval of Constitutional Updates

"Synod Council approves the updated constitution for St John's Oak Harbor." Motion made by Rev. Steve Ramsey; second by Rev. Brenda Peconge. Motion approved.

Action SC22.31 Grant to East Toledo Parish

"Synod Council approves a grant for \$7,000 from the Endowment Fund to assist with the formation of the East Toledo Parish."

Motion made by Deb Knoll; second by Rev. Mindy Elliott. Motion approved.
