3. Bishop's Update and Teaching Time – Led by Bishop Daniel

2023 is the Year of Story for the Northwestern Ohio Synod. Bishop shared three stories of faith and service. See Bishop's Report (Pages 11-14)

Liminal Leadership—leading into new reality – the space between historic and new (Learning: Greek—right thinking and more passive: Hebraic—direct investment and mentoring/apprenticeship: inherited church and emerging church—how to navigate the space between. Dual transformation – hybrid model. NWOS Diakonia program is an example of this hybrid investment model.

# **Action SC23.01 Synod Council Calls**

# **Action SC23.02 Approval of OLFC**

"At the recommendation of the Bishop, Synod Council approves the on leave from call status of: Pastor Brandi Bailie year 3 (Family Leave), and Pastor Meg Boger year 3."

Tom Ritter Deb Noll moved and seconded a motion to approve the recommendation. Approved.

## 5. Vice-President's Report

Nancy Yunker emphasized the importance of small groups within our parishes. How do we assess and then provide the leadership skills to help facilitate growing small group initiatives and provide the support? Looking for churches willing to participate in a pilot program.

# 6. Financial Report

### **Audit Report**

Required annual audit is required by the ELCA. Jacob Henry highlighted some portions of the audit report completed last summer. Issues found have been and are being addressed. The audit was a "clean" audit.

Shea Mc Grew presented the financial report. Jacob Henry highlighted portions of the 2023/24 Spending Plan, and Clark Price helped explain the proportionate sharing change.

#### Action SC23.03 Approval of the 2023/24 Spending Plan

"Synod Council approves the revised 2023/24 Spending Plan including a proportionate share of 40% of Mission Support income, and at the end of the year, will consider an additional gift should revenue exceed projections."

Corrected number for professional expense and continuing ed is \$14,000 instead of \$1500. Total operating expenses would be \$1,526,700 and the total net operation total would be (\$15,221).

**Bishop Beaudoin and Clark Price moved and seconded to amend the motion to include** "and at the end of the year, will consider an additional gift should revenue exceed projections". **Motion to amend approved.** 

Rev Robin Owen and Tom Ritter moved to approve the amended spending plan action. Approved.



# Action SC23.05 Designation/Disbursement of Office Sale Proceeds

"Synod Council approves the following allocation of net proceeds from the Bright Road office sale, totaling \$479,633.95: 10% donation to ELCA Mission Support, 45% to the synod's Endowment Fund, and 45% to the synod's operating reserves."

Deb Noll and Melanie Haack moved and seconded the motion to approve the action. Approved.

# Action SC23.06 DR and Endowment Disbursement Policy

"Synod Council approves the Donor Restricted and Endowment Disbursement Policy."

Correction to page 20, B. Candidacy and Training: "if operating candidacy/training expense exceeds the operating candidacy/training revenue,"

Robin Owen and Deb Noll moved and seconded a motion to approve the action. Approved.
