 - Redeemer Lutheran Church, Toledo- 2023 \$14,000 to 2024 \$12,600
 - Camino de Vida, Fremont-2023-\$10,000 to 2024 \$9,000

Total reduction of \$3800. Pastor Sarah has been in conversation with these ministry's leadership. Please pray about how we might support these important ministries.
