Action SC24.11 Approval of a Synod Council Continuing Resolution to establish a process to permit rostered ministers who are not "Under Call" to serve as voting members of the Synod Assembly.

SC24.12. "Synod Council approves the following continuing resolution for the Synod Constitution:

**S7.22A24** Retired rostered ministers, those granted disability status, or on leave from call, who are present at the Synod Assembly may have both voice and vote, provided that their inclusion as voting members does not result in fewer than 60% of the voting membership of the Synod Assembly being laypersons in contravention of S7.21, as determined by the Synod



Assembly's Credentials Committee. If their inclusion does result in fewer than 60% of the voting membership of the Synod Assembly being laypersons in contravention of S7.21, as determined by the Synod Assembly's Credentials Committee, the retired rostered ministers, those granted disability status, or on leave from call who are present at the Synod Assembly shall have voice but not vote."

## Motion to approve was made by Cindy Harris and seconded by Deacon Carolyn Steinfeldt.

"Synod Council approves the constitutional updates for Bethlehem, Pemberville, and Salem-Grace, Luckey."
